Abstract Submission Guidelines

- Your abstract should be max 250 words and written as a paragraph, max 2 abstracts per person.
- It should tell us how your system, product, service or point of view strongly contributes to the broader Mobility conversation, how it creates efficiencies, and builds on the overall national competitive ecosystem. You should not use this submission as a means of selling your organisation's products or services (the submission should not be a sales pitch).
- All submissions will be reviewed by a panel made up of subject matter experts representing industry, academia and government. Notifications will be emailed to submitters in April 2022.
- If successful, your abstract will be scheduled into the program and you will be informed of your presentation schedule. You will then be asked to complete your Speaker Registration by the end of April 2022. (All speakers are required to register, regardless whether presenting in-person or remotely.)
- A reduced registration fee is available for speakers.
- ITS Australia will deliver the event inline with government restrictions. Should the event pivot to hybrid or fully digital, there will be no refund and ITS Australia will have a conversation with you about the best way for you to give your talk.
